Elements of your data will be used to build a picture of all mortgage intermediaries within the UK, which will be held by our consultants and used by lenders to establish market share.

Information about you may be shared within Nationwide to prevent or detect fraud, or to assist in verifying your identity. We may also search the records of fraud prevention agencies which will supply us with information. If you give us false or inaccurate information and we suspect fraud, we will record this. We may pass information to financial and other organisations involved in fraud prevention to protect ourselves and our customers from theft and fraud. Nationwide reserves the right to verify the information you have supplied us with your employer/associated club or network if necessary.

Individual Intermediary

If a Group Supervisor has registered and been approved by your company Managing Director they will have the ability to:

- Transfer case owners within your company or group.
- Remove your access to Nationwide's systems.

If an Office Administrator has been assigned to you, they will have the ability to key mortgage information on your behalf.

Office Administrator

If a Group Supervisor has registered and been approved by your company Managing Director they will have the ability to:

- Assign an Individual Intermediary to allow you to key mortgage information on behalf of the Intermediary.
- Remove your access to Nationwide's systems.

If a Group Supervisor does not exist for your company or group, an Individual Intermediary will be able to assign you to them to act on their behalf.
